**Requested Service** URGENT door concern; "Receiving Area- Stairwell EXIT Door" pair of single unknown, metal door not holding secure, opening can be breached from exterior. Panic hardware, suspect rim panic latch disrepair or fault. Door condition unknown. Provide repair for proper latch ASAP. Determine further new parts as required. Security & Safety concerns.

**Job Progress Report** 4-2 In progress, repair ASAP. 4-2 Locksmith on site "Same Day Service". Inspected the noted door opening. Found pair of metal doors, center mullion & 2-rim panics, 1-panic device failed, 2-closers with 1-leaking oil, 1-minimal useful life remaining. Door hits center mullion post & requires some hinge align to correct for improved clear swing to positive latch. All suspect to disrepair & security concerns. We suggest: Install new 1-panic device, 2-HD closers and adjust door-hinges as needed. 4-3 Titan Doors advised SM, OK Install new panic device PRIORITY for repair. 4-3 Ordered 1-new panic hardware parts as required. 4-4 Tech on site, installed 1-new rim panic device "Equal or Better" with no outside trim. Door tested OK for improved latch security, corrected exterior breach concerns. 4-4 Job Completed.
